


## 40 ACHIEVABLE SDG TARGETS

 <p>1 NO POVERTY</p>	<p>1. Contribute to the eradication of extreme poverty within the <i>mine impact area</i>, with particular emphasis on people directly and indirectly impacted by <i>mine operations</i>, where extreme poverty is currently measured as people living on less than \$1.25 a day</p>
 <p>2 ZERO HUNGER</p>	<p>2. Double the agricultural productivity and incomes of small-scale food producers within the defined <i>mine impact area</i>, with particular emphasis on people directly and indirectly impacted by <i>mine operations</i>, by facilitating secure and equal access to land, other productive resources and inputs, knowledge, financial services, markets and opportunities for value addition and non-farm employment</p>
 <p>3 GOOD HEALTH AND WELL-BEING</p>	<p>3. Reduce the incidence of AIDS, tuberculosis, malaria and neglected tropical diseases and combat hepatitis, water-borne diseases and other communicable diseases within the <i>mine workforce</i> and communities within the <i>mine impact area</i></p> <p>4. Reduce the incidence of early death from non-communicable diseases within the <i>mine workforce</i></p> <p>5. Actively target the prevention and treatment of drug and alcohol use and abuse within the <i>mine workforce</i></p> <p>6. Achieve zero deaths from road traffic accidents involving company, contractor and supplier vehicles</p> <p>7. Strengthen the in-country capacity for early warning, risk reduction and management of national health risks</p>
 <p>4 QUALITY EDUCATION</p>	<p>8. Increase the number of youth and adults within the <i>mine impact area</i> who have relevant skills, including technical and vocational skills, for employment, decent jobs and entrepreneurship</p> <p>9. Expand the number of scholarships available to residents within the <i>mine impact area</i> for enrolment in higher education, including vocational training and information and communications technology, technical, engineering and scientific programmes</p>
 <p>5 GENDER EQUALITY</p>	<p>10. Ensure women's full and effective participation at all levels of decision making in <i>mine-related</i> matters in all communities within the <i>mine impact area</i></p>
 <p>6 CLEAN WATER AND SANITATION</p>	<p>11. Minimize <i>mine-related</i> pollution by eliminating dumping and release of hazardous chemicals and materials, avoiding the release of untreated wastewater and substantially increasing recycling and safe reuse of process and fresh-water</p> <p>12. Maximise water-use efficiency and ensure sustainable withdrawals and supply of fresh and process water to avoid adding to water scarcity in the <i>mine impact area</i></p> <p>13. Support the participation of communities within the <i>mine impact area</i> in improving water and sanitation management</p>

14. Maximize the use of renewable energy in the energy mix of the *mine operation*
  15. Maximize operational energy efficiency of the *mine operation*
  16. Support the expansion of infrastructure and upgrading of technology for supplying modern and sustainable energy services to communities within the *mine impact area*

17. Implement development-oriented policies and practices that support productive activities, job creation, entrepreneurship, creativity and innovation, and encourage the growth of micro-, small- and medium-sized enterprises within the *mine impact area*
  18. Reduce the proportion of youth not in employment, education or training within the *mine impact area*
- 
19. Support the development of quality, reliable, sustainable and resilient infrastructure to support economic development and human well-being for communities within the *mine impact area*
  20. Facilitate an increase in the access of small-scale industrial and other enterprises within the *mine impact area* to financial services, including affordable credit, and their integration into value chains and markets
  21. Facilitate increased community access to information and communications technology and the Internet within the *mine impact area*

22. Support the goal of achieving and sustaining income growth of the bottom 40 per cent of the population of the *mine impact area* at a rate higher than the national average
  23. Promote the social, economic and political inclusion of all people within the *mine impact area*, irrespective of age, sex, disability, race, ethnicity, origin, religion or economic or other status

24. Facilitate the development of local capacity for participatory, integrated and sustainable human settlement planning and management for all communities within the *mine impact area*
  25. Implement company policies and practices to protect and safeguard the cultural and natural heritage within the *mine impact area*

26. Implement company policies and practices to achieve sustainable management and efficient use of natural resources
  27. Implement company policies and practices to achieve the environmentally sound management of chemicals and all wastes throughout their life cycle
  28. Minimise operational waste generation through prevention, reduction, recycling and reuse
  29. Integrate sustainability performance related information into the company reporting cycle
